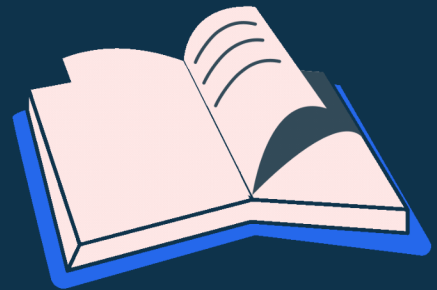
CCS Testing at the Conference Ed Shapiro - CCS Committee Chair



We are offering the Certifying Crane Surveyor (CCS) test for all 3 disciplines at the Conference. The normal online price is \$300 per test. At the conference, you can take the exam(s) for \$100 per test. The exams will be given from 9:30 am to noon on Tuesday the 30th.

The CCS Program was developed 22 years ago to provide credentials to members who were not in states that licensed inspectors or had Maritime Accreditation. Fast forward to today, we, as inspectors, are being asked for many credentials. Not only State Licensing and Maritime Accreditation but also OSHA 10 & 30 cards, TWIC cards, Scaffold Training for Tower work, Hazmat, and RAD. It is imperative to have the CCS designation for your type of inspection(s) to stay competitive.

Upon successful completion, you will receive a Certificate suitable for framing, and your discipline(s) will be noted on the reverse side of your wallet CCAA Membership card. Take advantage of this special offer that can only be available at a conference.
